

Use of Proceeds During IEO:

The use of proceeds is based on using quotes and market industry pricing to show how funding and token allocations are derived on the below tables in Phase-1 and 2 as cash disbursements at \$1,564,444 with \$35,556 reserve token value available. We anticipate a total Soft Cap raise to be at \$2 million with \$1.6 million for infrastructure and \$400,000 for campaigns, such as funding the 14-day training and trial period and media advertising services.

The fund-raising goal is set at \$1.6 million with an allocation from the Initial Token Supply (ITS) to offer IJJ tokens-priced at 5-cents with allocation of 32,000,000, to submitted for the IEO, we will mint 40 million ERC777 ready and available for the IEO, as required.

Under the On-Demand Order a preset price set at \$50 each. The Buyback mandates the acquisition of 150 IEO ERC-777 cryptographic hashed tokens are required as Retainer Tokens at 15-cents each with a total cost at \$22.62 + processing fees; estimated cost of goods at \$25.

The above On-Demand Order creates 150 Donator Backer Packages (DBP) at \$50 each or \$7,500 in sales to DBs. To create one Buy 1 requires 1 ERC-777 with 150 ERC-223 furnished by IJJ Corp coming from the ITS as Reward account tokens to create distributions and to meet On-Demand. For 272 million ERC-777 will require over several years 4.8 Billion ERC-223 Account receipts.

The following table provides a breakdown of the use of proceeds in Phase-1 and 2 with that will occur in 2-staging periods as shown in the Timeline over the 10-month period from January to October 2020.

The Use of Proceeds do not include proforma financial projection statements, only provides the use of funding raised from the IEO.
